Dear Parent/Guardian:

I am pleased to inform you that your child has been provisionally accepted to attend the Magnet school listed above for the 2009-2010 school year. This acceptance is subject to a determination by your child's Individualized Education Plan (IEP) team that the proposed Magnet program can meet your child's unique educational needs and can offer a Free Appropriate Public Education (FAPE) for your child. Please call your child's current school of enrollment to schedule an IEP meeting. **This IEP meeting should be conducted prior to placement at the Magnet school.**

**If you accept this Magnet assignment, continued attendance or new enrollment in any year-round calendar school as of July 1, 2009 will cancel this acceptance letter.**

Magnets will operate in accordance with the District's Standards-Based Promotion policy. Those students who do not attain the next grade level will be required to successfully complete District requirements before they are eligible to enter the next grade. It may be possible to hold the Magnet placement until the first week of September if the student successfully completes the summer intervention program. If students are not successful in the intervention program, their parents must notify the Student Integration Services and will need to reapply for the next school year.

Transportation is provided for applicants if they reside outside a two-mile radius or outside the Magnet school attendance boundary, whichever is further. Before the opening of school, those students eligible for transportation will receive notification by mail of pick-up time and location. **If you accept this placement, your child will be transported according to the Magnet program guidelines at pre-established stops.**

**It is important if you decide not to accept this Magnet assignment, that you call within a week of receiving this letter to notify the school of your decision.**

All information on the Magnet application is subject to verification, including that pertaining to the student's ethnicity and address, which may be verified by school personnel. As stated on the application, falsification of information will result in the student's removal from the program.
